Fellows will have an opportunity to translate academic insights for a policy audience, explore new frontiers of policy ideas and solutions, and contribute meaningfully to the formation of future policy that serves the people of NSW.

Fellows will be required to undertake analysis of a significant policy challenge or opportunity in NSW, and develop bold yet feasible recommendations for public policy and government action, backed by relevant evidence.

Fellows are expected to produce a Policy Insights Paper to be published by the Institute, communicating their analysis and recommendations.

While the work of the Fellow will be largely self-directed, , the Institute will provide editorial and research guidance, advice and support on engaging with policymakers and other stakeholders (including the possibility of a roundtable upon completion of the report), assistance with the design of the report, and communications support – all of which is intended to maximise the fellow's public policy impact.

Fellowships will be for a period of 6-12 weeks. Fellows will have the title of 'Senior Policy Fellow' (for those at the professorial level) or 'Policy Fellow' for the duration of their fellowship. For more information, please contact <u>Annette McLaren</u>.

About the JMI Policy Fellowship – Academic stream

The JMI Policy Fellowship (academic stream) at the James Martin Institute for Public Policy provides suitably qualified academics with the opportunity to pursue independent and rigorous policy-relevant research with a strong potential to generate public value and impact.

Fellows will have an opportunity to translate academic insights for a policy audience, explore new frontiers of policy ideas and solutions, and contribute meaningfully to the formation of future policy that serves the people of NSW.

Fellows will be required to undertake analysis of a significant policy challenge or opportunity in NSW, and develop bold yet feasible recommendations for public policy and government action, backed by relevant evidence.

Fellows are expected to produce a JMI Policy Insights Paper of approximately 5-15 pages, to be published by the Institute, communicating their analysis and recommendations for a policy audience.

While the fellow will be largely self-directed in their work, the Institute will provide editorial and research guidance, advice and support on engaging with policymakers and other stakeholders (including the possibility of a roundtable upon completion of the report), assistance with the design of the report, and communications support – all of which is

intended to maximise the fellow's public policy impact. Fellows in 2023-24 will be allocated up to \$10,000 for direct research costs.

Fellowships will go for approximately 8-16 weeks. The length and timing will be tailored for each fellow.

Fellows will have the title of 'Senior Policy Fellow' (for those at the professorial level) or 'Policy Fellow' for the duration of their fellowship.

Applications will be reviewed on a rolling basis.
