Policy	Status
<i>Advanced Standing Policy</i>	The revised version approved by Academic Senate on 21 October 2016 has been published. The implementation plan was discussed at 24 May APAG meeting.
<i>Articulation Pathways Policy</i>	The 26 October 2016 APAG meeting discussed a proposed new version of the <i>Articulations Policy and Procedures</i> . This version was further amended to align with the new Partnerships and Pathways Framework. Consultation has occurred and the policy, procedures and a delegations document are on this agenda for consideration at Item 3.11.2.
<i>Course Design Policy</i>	The Terms of Reference and membership for the Working Party have been agreed noting that this work will be heavily influenced by the 21 st Century Curriculum Project, with guidance from the Project Implementation Advisory Group. Amendments to the <i>Postgraduate Coursework Policy</i> regarding Graduate Certificates are being investigated by OQP for any necessary compliance updates.
<i>Disruption to Studies Policy (renamed from Special Consideration Policy)</i>	The new <i>Disruption to Studies Policy</i> and associated guidelines were approved at the 21 October 2016 meeting of Academic Senate. An implementation plan is being devised which may involve alignment of some other processes.
<i>Lecture Recording Policy Review</i>	A draft revised <i>Educational Video Policy</i> was discussed at the 24 May APAG. Development is continuing via LaTTe.
<i>Progression and Unsatisfactory Academic Progress</i>	A revised <i>Progression Policy</i> was agreed at the 16 February meeting of APAG and endorsed at the 7 March meeting of Education Committee. The new policy will be provided to the October meeting of Academic Senate for consideration.
