3. GENERAL BUSINESS

3.1 STUDENT MANAGEMENT SYSTEM UPDATE

Ms Libby Hughan, Senior Manager, Student Systems presented the Student Management System (SMS) Update to Senate.

Degree Works went live to students on 31 October 2022 and although the initial volume of student enquires was low, it is expected to increase following results release. The Program Compliance Team within Data Integrity, Quality & Operations (DIQO) has been established and will take ownership of enquires.

The processing of Spring Results is almost complete with 29,767 students having received their results, and 6,500 students still have results outstanding. The main reasons for this are placement outstanding, results not yet finalised and deferred exams.

System improvements continue to be implemented, with notable achievements being:

- Student Journey
 - Degree Works launch for Students
 - o 2023 handbook
 - Refinements to UAC Admissions processes
 - Improved Deferment Management process
 - First full year of results processing in RePS
- Compliance & Government Reporting
 - o Verification of 2021 TCSI data
 - o Improvements to TCSI error management. This work is ongoing
 - AHPRA reporting

- System Maintenance
 - o Enhancements to RePS after Autumn Resulting
 - o Improvements to Assessment item management functionality
 - o First Banner upgrade
 - o Implementation of Data Integrity Processing Framework ODIN

The Senate viewed the roadmap which contains approximately 200 project activities, with priorities for 2023 focusing on reporting, providing a better student experience, removing manual interaction and general overall improvement. It was noted that the only delay is regarding the automation of conferrals.

The Senate was informed that a fortnightly SMS User Group is held for academics to bring forward any issues with the SMS. The SMS Team is also happy to attend other meetings.

The Vice Chancellor acknowledged the achievements by the SMS Team and in bringing many functional areas of the University together.

The Chair thanks the SMS team for their efforts and reinforced that Senate will continue to monitor the implementation progress.

3.2 URBAN TRANSFORMATION RESEARCH CENTRE – PRESENTATION

Professor Nicky Morrison and Professor Greg Morrison, Co-Directors of Urban Transformation Research Centre presented to the Senate on the Urban Transformation Research Centre (UTRC).

The UTRC launched on 4 November 2022, with the entire event recorded. The recording will be shared with Members of the Senate, as well as the online brochure.

The challenge of the UTRC is how to transform our communities and infrastructure into sustainable, equitable and resilient futures with the UTRC's mission to deliver action-oriented research to enable impact at scale.

The University's international number one ranking has allowed for the UTRC to driving these initiatives and as the UTRC is located within the heart of Parramatta, many agencies and partners have approached the UTRC, wanting to work together in this space.

The UTRC's partners inform and drive what research projects are prioritised, and a forum is being organised at the leadership level to determine the best process for this collaborative approach to be implemented.

One of the considerations is the creation of a project membership pool, where key project personnel can be drawn from, based on skills and experience, when a project is undertaken.

The UTRC's External Advisory Board, which is a key strategic entity had their first meeting on 16 November 2022, and outcome of which is the preparation of the draft strategy plan.

The UTRC is has built close working relationships with 'Climate KIC' which orchestrates collaborative efforts to deliver connected and coordinated climate action, and areas within Europe to work towards the Australia Net Zero Cities for 2030. The UTRC also has a significant presence in the Western Parkland City, Hawkesbury Circular Economy Hub, Penrith Sustainable Innovation Community, Lend Lease and

Sydney Science Park. The UTRC is also a core partner on the Cooperative Research Centres 'Waste 2 Wealth' bid, of which they are awaiting an announcement.

3.3 CHAIR'S REPORT

A written report from the Chair covering activities undertaken on behalf of the Senate since 14 October 2022 has been circulated. The Chair provided an update on any recent developments. The Chair's report to the 7 December 2022 meeting of the Board of Trustees, was appended to the Chair's report.

The Chair attended the NSW/Territories Committee of Chairs of Academic Boards/Senates (CO-CAB) meeting that was held on 10 and 11 November 2022 at University of Technology, Sydney.

Key topics discussed at the meeting were:

- Contract cheating is a very important and challenging issue faced by all universities. A partnership approach should be adopted with collaborations between institutions, TEQSA and students to enhance the sharing the resources and intelligence on contract cheating.
- Early Offer/Entry Scheme for year 12 students where it was noted early offers attract wide interest, even in year 10 students. Joint discussions among schools, universities and students should be developed to ensure early offers do not disadvantage students and ensure the enrolled student can transit from school to university smoothly and ensure students be successful in universities.
- Developing industry ready graduates including technical skills, digital competencies, lifelong learning skills (curiosity, critical thinking, problem solving, leadership, collaboration, emotional intelligence, resilience). An important issue discussed was how to develop these skills in the academic programs and how to assess key skills.

The Chair noted that since the last meeting of the Senate, the Progression Panel has completed 60 Show Cause against Progression Outcome applications submitted by students and the Academic Appeals and Integrity Panel has processed 23 appeals received by students. The Chair thanked both Panels for their work in these areas.

The Chair invited Chairs of the Standing Committees of Senate to provide an update:

Professor Clare Pollock, Senior Deputy Vice-Chancellor

Australian Universities Accord

Western Sydney University will have three opportunities to provide input/feedback. The first opportunity to provide input if due mid next week, noting that it is not in relation to the content of the accord.

The second opportunity is expected to be mid-February 2023. With the key points to be raised will be regarding access/equity to university and knowledge/skills development. Requests to fix issues identified with the Jobs-ready Graduates Package (i.e. 50% failure rate, student attendance rate, etc.) should also be made a high priority.

An interim report on priority actions is anticipated to be made available by June 2023, and this should be discussed at the August meeting of the Academic Senate regarding the Universities response to the interim report.

Professor Simon Barrie, Deputy Vice-Chancellor (Academic)

Professor Simon Barrie reported on the Academic Planning and Curriculum Approvals Committee:

- Work is being undertaken to contextualise reports on the masters programs as part of the Postgraduate Transformation (PGX) initiative.
- Dr Nicolene Murdoch is leading the innovation and implementation of the Curriculum Design and Approvals Policy.
- A full report on the Academic Planning and Curriculum Approvals Committee was circulated in Item 4.2.

Professor Deborah Sweeney, Deputy Vice-Chancellor and Vice-President (Research, Enterprise & International)

Professor Deborah Sweeney reported on the Research Committee:

- Thank you to all members of the Research Committee and to those who attended the Research Quality Forums.
- Work continues into improving the quality of publishing and provide further information into research statements into Schools and Institutes to provide targets and metrics, specifically those who want to publish in books.
- Developing research champions to get more people from across Schools to be involved in research activities.
- Information will come before Senate in 2023 regarding the research conducted in Schools and Institutes throughout the year. It will be a good opportunity to celebrate these achievements.
- A full report on the Research Committee was circulated in Item 4.5.

Professor Michelle Trudgett, Deputy Vice-Chancellor (Indigenous Leadership)

- Western Sydney University currently has 846 Indigenous students, which significantly increases the competitive nature of the University, over 100 Indigenous staff, which means Western Sydney University's Indigenous community is approximately 1000 people.
- We are in the progress of finalising several strategies and plans. Every School now has an Indigenous Strategy and it should be noted that the STEM Cluster Board has endorsed a STEM Cluster Indigenous Strategy.
- A key focus of 2023 will be on buildings and placemaking. Early in the year, the First Peoples Walk. There is significant work being done around Indigenous languages and incorporating it into each campus.

Professor Clive Baldock, Dean of Graduate Studies and Researcher Development

Professor Clive Baldock reported on the Research Studies Committee:

- Due to issues raised by Student Members of Academic Senate, the base stipend has been increased by 5% to \$31,500, with potentially another increase for 2024. This is in response to siding living wages and will assist with marketing Western Sydney University. All candidates with Western Sydney University in January 2023 will be paid the new stipend.
- In 2023, Western Sydney University is able to offer 182 scholarships.

Graduate Research School (GRS) Review Implementation

In response to the GRS Review the following staffing changes have occurred:

- Professor Janice Aldrich-Wright appointed as the Deputy Dean
- Dr Alex Norman appointed as the Director of Academic Program
- Ms. Tara Faull is the Acting School Manager
- Recruitment is being undertaken to fill the new position of Director of Graduate Research

Significant work has been undertaken with the Research Master System, which went live in September 2022. The work has been completed on 14 HDR eforms with minor updating of three remaining. To date there has been 645 forms submitted (413 candidature milestones, 168 candidature variations and 64 thesis submissions and examinations). The next body of work will be in the ethics system.

Dr Nicolene Murdoch, Pro Vice-Chancellor (Educational Partnerships and Quality)

Dr Nicolene Murdoch reported on the Senate Education Committee, Senate Assessment Committee and the Third Party Provider Committee:

<u>Senate Education Committee and Senate Assessment Committee</u>

- Significant work being done on the Academic Integrity Strategy Document, which is going through both Committees.
- Work is being done on a more in-depth analysis of the QILT data to inform our Engaged Teaching project.
- Work in the benchmarking of assessments and an examination of how to streamline the process is being undertaken.

Third Party Provider Committee

- Have concluded reviewing comments received regarding the 12-month review into the Third Party Provider Policy.
- Work undertaken into incorporating the results of third party providers into the Student Management System. Thanks to the School of Business for assisting with this process.
- Have reviewed annual reports from international third party providers.

3.4 VICE CHANCELLOR'S REPORT

This item was discussed in the middle of the of Item 1.6 – Minutes of Previous Meeting'.

The Vice-Chancellor's report had been circulated to the Senate.

The Vice-Chancellor highlighted the following from their report:

Quality Indicators for Learning and Teaching (QILT)

Discussion have occurred at the Board of Trustees regarding the Western Sydney University QILT results and has raised concerns regarding the 'stubbornness' of some categories. We need to do a deep assessment of the QILT survey results, we need to understand response rates and alignment. It will be an important opportunity for Senate to review the findings.

On Campus Experience

A major focus for 2023 is the building of campus life. There have been discussions regarding the return of students to campus but there is a responsibility for University staff (both academic and professional) to also return to campus and lead by example for the students. As a result of COVID, the University has implemented work from home arrangements and the use of Zoom has brought many benefits to staff and students (i.e. hybrid model of learning) but moving forward we need to ensure staff are utilising their spaces on campus, otherwise they can be repurposed.

A Student Member raised that if the aim is to bring students onto campus to build campus life, it will require different strategies than students returning to campus for study. This is due to different needs and priorities between class engagement, campus engagement, study engagement, etc.

The Vice-Chancellor acknowledged the point raised and reinforced that there is no single solution and a suite of responses will be required. The Vice-Chancellor thanked the Senate for their discussions on this topic and would like to continue them early next year.

Australian Universities Accord

Professor Clare Pollock is leading Western Sydney University's response to the Australian Universities Accord.

The minister has raised concerns regarding the equity of access to/participation in university and the and graduate employability of Western Sydney University students. The Accord will also consider a range of issues on research, teaching, learning and national governance. It is important for Western Sydney University to lead the discussions in this. The Australian Universities Accord was not established to develop short term solutions in response to issues within the university sector but develop long term solutions that will continue through changes in state and national governments.

An interim report is expected to be released in June 2023 with a final report expected in December 2023.

International Opportunities

As international travel is opening up, it is pleasing to see colleagues are able to undertake international travel opportunities. Another focus for 2023 is the opportunity to connect with our international partners and establish new relationships overseas.

International Students

We have seen a significant change within the international student body as the implementation of Zoom and hybrid style learning has resulted in a number of international students are not studying domestically, which is seen not only by the University but financially on the surrounding communities.

In response to a question by a Member regarding The College and its involvement with international students, the Vice-Chancellor acknowledged its success but also stated that it is now under pressure due to other universities implementing a similar model. It is noted that The College RTO still retains the ability the pickup skill shortage needs, and the upcoming implementation of micro-credentials will be an important step forward in this space, especially if we can get the national framework right.

The Vice-Chancellor acknowledged the vitally important work undertaken by the Academic Senate and thanked Professor Sarah Zhang for her extraordinary work as the Acting Chair while Professor Robert Mailhammer was undertaking the Academic Development Program.

3.5 STUDENT REPORTS

3.5.1 DISTRIBUTION OF LEARNING GUIDES/SUBJECT HANDBOOKS

Ms. Sammie Burrett, Student Member (Disability Representative) presented a paper on the issue of Learning Guides/Subject Handbooks being distributed late, impacting on students. It was noted that this issue effects not only impacts students with disabilities but the entire student body.

The Curriculum Publication Procedures state that handbook content should be published at least two weeks prior to the commencement of each term where the subject is taught (clause 14) and Learning Guides available at least one week prior (clause 19). It has been reported that some students are not receiving Learning Guides until a few weeks into their studies.

Ms Debra Farrelly (Pro Vice-Chancellor Student and University Planning) provided statistics regarding the distribution of Learning Guides/Subject Handbooks throughout Autumn and Spring 2022, noting that there were issues with some material not being distributed until week four.

The Senate noted that this is an area that requires improvement and policy should be followed and implemented. The Senior Deputy Vice-Chancellor and Provost informed the Senate that she would follow up with the Deans regarding this issue. An update will be provided to Senate at a senate meeting around mid-2023 by Debra Farrelly when the updated data are available.

It was noted that the Learning Guides/Subject Handbooks distribution data was provided to the Senate Education Committee in the past, and it is encouraged to once again be raised there.

3.9 APPROVAL OF ACADEMIC SENATE STANDING COMMITTEES TERMS OF REFERENCE CHANGES

3.9.1 THIRD PARTY PROVIDER COMMITTEE

The Senate was requested to consider and approve terms of reference changes to the Third Party Provider Committee, as noted in the appended paper.

Summary of proposed changes:

- Inclusion of meeting frequency 'The Third Party Providers Committee will meet 6 times per year, as required. E-meetings may be scheduled at the discretion of the Chair to consider urgent matters.'
- Inclusion of standard quorum provisions 'Quorum is one-half (or if one-half is not a whole number, the whole number next higher than one-half) of the total number of members for the time being of the Committee. If quorum is not present within 30 minutes of the stated commencement time, the meeting shall automatically lapse and the business on the agenda shall be included in the agenda for the next meeting.'
