## **Project Summary**

Partnership pedagogy (PP) is a key component of Western Sydney University's transformation of curriculum, allowing the University and its students to remain engaged with emerging social and ecological challenges and prepare them for complex future work environments.

The <u>Teaching and Curriculum Partnerships</u> Program of Research (TCP PoR) aims to build a comprehensive understanding of work-integrated learning and industrial linkages from the perspectives of staff and students at WSU.

Partnership Pedagogy is a transformative approach to curriculum that benefits students, staff, partners and the university.

If you do choose to opt out, no further information will be collected, however, some information you may have supplied previously may be used in subsequent analysis.

For subprojects of this Program of Research, if you have not opted out, you may be contacted to request your participation in surveys, focus groups, or similar research activities. Subproject researchers must gain your explicit consent for participation, and you are not obliged to participate in these subprojects and may opt out at any time.

## **Information Storage and De-identification**

Please be assured that only the central team will have access to the raw information collected for this Program of Research. However, your information may be used in further partnership perdagogy-related projects for an extended period of time – for example, once the approval for the TCP PoR has expired a new Program of Research will be sought that will include allowing researchers to access the eligible information collected under this program of research.

The information for this Program of Research will be stored securely for a minimum of ten years in password-protected servers.

## What will happen with my information if I agree to it being used in subprojects?

These subprojects will focus on the research on and evaluation of specific themes or programs of work-integrated learning and partnership pedagogy at Western Sydney University. Only your data that is related to work-integrated learning and academic progress will be made available to researchers; the Partnership Pedagogy central team will only allow subproject researchers access to your information that directly relates to their subprojects. For example, preparation for workplace placement may be conducted in a new format in one year, and subproject researchers wish to compare students' academic progress and satisfaction to those in previous years.

Subprojects that wish to collect any further information for you (such as your participation in a focus group) must obtain your explicit consent for your participation and will provide full details on what will happen to your information if you consent to be part of the subproject.

The researchers are asking that you agree to the use of your information (data) in this project and to agree to allow the data to be used in future research subprojects.

You are being asked to agree to your routinely collected and de-identified student information being used for research on partnership pedagogy at Western Sydney University.

#### **Extended consent**

When you agree to extended consent, it means that you agree that your data, as part of a larger dataset (the information collected for this project) can be re-used in subprojects that are dataset (the information collected for this project) can be re-used in projects that are

- an extension of this project
- closely related to this project
- in the same general area of this research.

This request is in line with current University and government policy that encourages the re-use of data once it has been collected. Collecting information for research can be an inconvenience or burden for participants and has significant costs associated with it. Sharing your information with other researchers gives potential for others to reflect on the data and its findings, to re-use it with new insight, and increase understanding in this research area.

To enable the re-use of data, it will be held at the University in its data repository and managed under a Data Management Plan. The re-use of the data will only be allowed after an ethics committee has agreed that the new use of the data meets the requirements of ethics review. Only access to demonstrably relevant and directly related to partnership pedagogy data will be allowed.

The researchers will allow this data to be used by other projects on partnership pedagogy and teaching methods, or those in the general research area of student experience. To enable this re-use, your data will be held at the University in its data repository and managed under a Data Management Plan. The stored data available for re-use will not have information in it that makes you identifiable. The re-use of the data will only be allowed after an ethics committee has agreed that the new use of the data meets the requirements of ethics review.

The researchers want to keep the data for five years for possible re-use. After this time the data will be securely destroyed.

You are welcome to discuss these issues further with the researchers before deciding if
