From 1 January 2016, those wishing to register as a Tax (Financial) Adviser or Tax Agent will be required to meet qualification and experience requirements as set out in Schedule 2, Part 3 of the Tax Agent Services Regulations 2009 (TASR).

The University has approval from the TPB to deliver courses in Australian tax law and commercial law for tax (financial) advisers and tax agents.
