Handbook Summary

Integrated Clinical Rotation 3 is the first session of the third major clinical year of the MD program. It consists of five weeks in Medicine, Surgery, General Practice, Aboriginal Health, or ICU, ED & Anaesthetics. There will also be one Conference Week where all students will be based at either Campbelltown Campus, Macarthur Clinical School or Blacktown Clinical School. Students will be based at a number of appropriate hospitals throughout Sydney, Bathurst and Lismore. Students will also undertake 2 online learning modules (Scientific Streams). Students will complete a reflective portfolio. The Rural Clinical Schools may blend some of the clinical attachments between ICR2 and ICR3 (ie: some ICR3 attachments may be delivered in the 2H Year 4 and some ICR2 attachments may be delivered in the 1H Year 5), however by the end of ICR3 all students must have completed the attachments prescribed for ICR2 and ICR3.

If a student fails to produce this documentation to ClinConnect they will be unable to attend their hospital tutorials and placements. Attendance at the hospital is a mandatory requirement of the Unit and failure to attend will result in a Fail Grade of the subject. The documents that are to be provided to ClinConnect are:

The School of Medicine has moved to an overall non-graded assessment system, whereby all the above will contribute to a satisfactory or not satisfactory overall assessment for ACS3. This won't affect individual assessments but will mean that an overall numeric grade will not be given. Satisfactory ("pass") means a good overall competent standard for ACS3.

### Progression rules:

Threshold: Threshold assessments are compulsory requirements within the subject that must be met in order to pass the subject. They include mastering professional skills and/or attainment of required professional attributes. Failure to satisfactorily complete a Threshold requirement will result in a Fail Grade for the subject.

In order to be eligible for a "Satisfactory" grade in ICR 3, Students must:

- a) \*Achieve a mean score of 50% or higher after standard setting has been applied in papers A-C combined (all from the same sitting attempt); and: achieve 50% or higher after standard setting has been applied in two out of the three written exams (Papers A-C, all from the same sitting attempt) -- if successful in reaching all of these requirements then the student will receive a "Satisfactory" grade for the Written Examination; if sitting a Supplementary Examination then all three papers will need to be sat and the marks from earlier attempts disregarded.
- b) Have attained a "Satisfactory" grade for each clinical attachment. If a student fails an attachment they will be given one opportunity to remediate that attachment as prescribed by the Head of Discipline. If a student fails the remediation, they will receive a Fail Grade for ICR3.
- c) Have not failed two or more attachments in ICR3. If a student fails two or more attachments, on their first attempt, they will receive a Fail Grade for ICR3, regardless of whether the remediation attempt for the first failed attempt of a single attachment was successful. That is, only one clinical attachment remediation opportunity will be offered within ICR3.
- d) Have completed the **Scientific Streams** at a satisfactory level in the designated timeframe. Students with unsatisfactory participation or two warnings for late submission of work, will be given one chance at remediation by the Scientific Stream coordinator. Failure to satisfactorily complete the remediation task for the Scientific Streams will result in an "Unsatisfactory" grade being given for this Threshold assessment, resulting in a Fail Grade for the subject.
- e) Have met attendance requirements as outlined in the School of Medicine Attendance Policy, Applied Clinical Sciences which can be found in the 400977 Learning Guide: Attendance Requirements & Protocols for the MB BS program.
- f) Students must behave professionally at all times and comply with codes of conduct and policies for professional practice as outlined by:

Failure to uphold these inherent requirements and professional standards may result in the student being awarded a Fail grade for the subject.

g) If a student withdraws from the subject prior to the session 1H census date no academic penalty is imposed and no grade is recorded on the student's academic transcript. If student withdraws from the subject during session 1H, after the census date, they will receive an 'E' grade (Fail Discontinued) on their academic transcript. The last date to discontinue after census is the Friday that is two weeks before the published start date of the exams for the session. For an explanation of the UWS grade award, please see

Students who have satisfactorily passed 1H assessments will be awarded a Y grade (Continuing) until their final grade for the Subject is determined after all assessments are completed for the subject. If a student has been awarded a Y grade (Continuing) in the subject, having completed as least one session of study, and subsequently withdraws from the subject, the Y grade will be converted to a 'F" grade (Fail) for the subject. In the event of serious illness or misadventure experienced by a student after the session 1H census date, the student may apply for a W grade (withdrawal without academic penalty) through the official University processes.
