1.8 Arrangement of Business

2. REPORTS

2.1 Chancellor's Report [Open Session Item]

The Chancellor spoke to her report, noting the following:

- *Australian Universities Accord*: The Chancellor is a member of the Australian Universities Accord Ministerial Reference Group and provided an update from the most recent roundtable with the Minister. The Business Council of Australia (BCA), of whom the Chancellor is the Chief Executive, has also met with the Accord Panel to discuss the role the BCA can play to strengthen the position of universities.
- *Individual meetings with Board members*: The Chancellor has met with most members of the Board and will provide a report at the next meeting once all one-on-one meetings with Board members have been completed.
- *Jobs and Skills Australia*: The first meeting of Jobs and Skills Australia (JSA) has taken place. JSA will work with the Australian Universities Accord.
- *Board of Trustees Induction Session*: The Chancellor highlighted her key messages to new members at the recent Board of Trustees induction. This included the Board's role in assisting the management team to maintain momentum, ensuring collegiality, raising concerns with the Chancellor prior to Board meetings, and the importance of ensuring that the staff and student voice is heard.
- *Stepping down from the BCA*: The Chancellor spoke to the recent media announcement of her stepping down from the BCA, with a date yet to be determined.
- *Western Parklands City Authority (WPCA)*: WPCA has signed a letter of intent with the NSW Vice-Chancellors' Committee regarding education and research opportunities in Bradfield.

- *Trip to India*: The Chancellor will travel to India with the Prime Minister, which will be an opportunity to showcase the University's strengths and strong connections to India.
- *Voice to Parliament*: There will be a session at a future Board meeting on the Voice to Parliament.
- *Australian Institute of Company Directors (AICD) Course* – The Chancellor encouraged members to attend an upcoming AICD course on University Governance.

2.1.1 Vice-Chancellor's Performance Plan and University Achievements and Challenges in 2022 and Priorities for 2023 [Closed Session Item]

2.2 Vice-Chancellor's Report [Open Session Item]

The Vice-Chancellor highlighted the following items in his report:

- *Australian Universities Accord*: the Panel has released a discussion paper which will be circulated to all members of the Board. A deep-dive presentation has been scheduled with Board and Committee members for 2 March. Submissions to the paper are due by 11 April, with the Panel's interim report expected to be released in June.

- *Council of International Education*: the Vice-Chancellor met with the new Council to discuss its overlap with the Accord.
- *International Travel*: in the week commencing 27 February, the Vice-Chancellor will be in India as part of a Ministerial led delegation, which will include a focus on agriculture

research and training. The Vice-Chancellor will travel to China in March with a delegation of Associate Deans (international), to reengage with partners in the region.

- *Student load update:* the sector is experiencing a softening in domestic student load. The Vice-President, People and Advancement provided an update, advising that despite this trend, the University is on target for commencing load, and that International student load is also performing well. Sydney City Campus and OEC are also on track to meet their targets. Continuing load remains soft, largely due to the strength of the economy and current job market. The University has introduced strategies such as study scholarships to assist with improving load. The Vice-Chancellor advised that the University is holding a contingency in the budget to address any shortfall in load.
- *WestInvest:* the University has been awarded approximately \$78.5 million in funding from the WestInvest program to establish an Indigenous Centre of Excellence at Parramatta South campus. A national design competition will be held, focussing on indigenous practices and architects. The Vice-Chancellor spoke of additional funding awarded from the WestInvest program that positively impacts the University, including projects in Liverpool, Bankstown and Penrith.
- *Vietnamese Vice-Foreign Minister and Ambassador Delegation Visit:* the University hosted a Vietnamese delegation led by the Vietnamese Vice-Foreign Minister, the Vietnamese Ambassador and the Vietnamese Consul-General, which provided an opportunity to discuss the University's research and education engagement in Vietnam. Following the delegation visit, a roundtable discussion was held to explore opportunities for collaboration in education, teaching and research between Vietnam and Australia.
- *Adapting to Generative Artificial Intelligence (AI):* much work is underway on how the University is responding to the challenge of generative AI. A key focus of the University's response is to ensure that members of the University community are supported and prepared for the ethical use of generative AI in their learning and work, while ensuring the integrity of credentials and scholarly knowledge creation. This will also inform work on the student experience.
- *ATEM Awards for Excellence - 2022 Best Practice Awards:* the Board congratulated the Deputy Vice-Chancellor Indigenous Leadership and the team on being awarded the Best Paper Award at ATEM's Best Practice Awards in Tertiary Education Management.
- *Cyber Security:* the Board discussed cyber security risks and external assessments of the University's cyber risks. The Senior Vice-President advised the Board that the University's cyber security framework is mapped against multiple assessments, including the Essential 8 and Mandatory 25. The Board were advised that the newly appointed CISO is leading the cultural change required to ensure cyber security is everyone's responsibility.

2.3 Academic Senate Report [Open Session Item]

The Chair of Academic Senate thanked Professor Sarah Zang, members of the Senior Executive and the Office of Governance Services for the support during his leave, and spoke to the report, noting:

- *Student Report:* the Student Member's Report to Senate continues to create a positive impact by raising key issues for Senate to consider. For example, addressing the late distribution of Learning Guides, and increasing the HDR stipend.
- *Australian Universities Accord:* the Academic Senate will contribute to the University's response to the Australian Universities Accord, via its standing committee.
- *VC and Academic Senate Form:* a forum will be held in July/August to discuss the Australian Universities Accord, and the issues and challenges raised.
- *TEQSA Renewal:* Academic Senate is assisting with preparations for the 2025 TEQSA reaccreditation submission, under the leadership of the Deputy Vice-Chancellor (Academic).
- *Generative AI:* Board members discussed Senate's role in fostering the opportunities that AI presents as a tool to assist pedagogy, and it not only being a cheating risk to be

managed. It was agreed that a future Board deep-dive session will be held on the impacts of generative AI.

The Board noted the report which demonstrates that the University is fully compliant with both the Voluntary Code for the Governance of Australian Universities, and the TEQSA Corporate Governance Standards.

3.3 Transformation Program Update [Open Session Item]

The Senior Vice-President updated the Board on the following aspects of the Transformation Program:

- *Digital Acceleration (DX)*: The project is gathering momentum and there is now a roadmap on how to reshape the data governance and new functional structures. The new telephony system has now been installed, moving from analogue to digital.
- *Destination College (DC)* – a series of pilots have been finalised, and the project is working towards refining the reduced set of programs to be delivered.
- *Innovation Futures (IF)* – curriculum development and partner identification are complete, and the project has successfully delivered Venture Maker components within Humanities and Communication Arts (HCA) subjects.

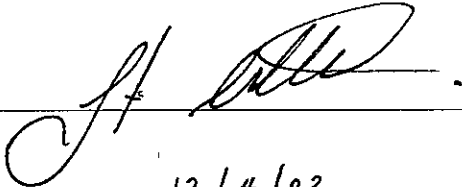
