### Welcome

The Chair of Academic Senate, Associate Professor Paul Wormell, welcomed all members of Academic Senate to the second meeting for 2017.

The Chair opened the meeting by reading an Acknowledgment of the Traditional Owners, paying his respects to their Elders, past, present and future, and extending a warm welcome to all Aboriginal and Torres Strait Islander people attending the meeting.

A special welcome was extended to Associate Professor Paola Escudero, a new member representing the University Research Institutes, and Associate Professor Juan Salazar, representing Professor Paul James, who is also a University Research Institute representative. The Chair noted that this would be the first meeting for Senate's new undergraduate student member, Ms Janice Yane. He extended his thanks to Mr Jarrod Bradley, whose term as an undergraduate student member concludes on the 31st of May, and wished him well for the future.

The Chair welcomed Ms Alyssa White, Senior Governance Officer, to her first meeting of Academic Senate.

The Chair also welcomed those in attendance from Schools or Institutes reporting later in the agenda, and acknowledged the large amount of hard work that the School and University Research Institute committees do on behalf of the University. The first Senate meetings for 2017 aim to highlight this, as well as completing a full set of Committee reports to Senate. These reports are essential for transparency and good academic governance, which is one of the focus areas for our re-registration by TEQSA. It also allows for appropriate recognition and appreciation to be given to some very active committees, as they share information and good practice through their reports to Senate.

#### 3 GENERAL BUSINESS

#### 3.1 REPORT FROM THE CHAIR

Senate had before it a written report from the Chair covering activities undertaken on behalf of the Senate since 17 February 2017.

Additionally, the Chair acknowledged the passing of Dr John Hayes, a leading chemical educator at the Hawkesbury Campus in the 1980s and 1990s. John was a generous mentor and a resolute defender of academic quality and standards.

### 3.2 REPORT FROM THE VICE-CHANCELLOR

This item was unstarred as the Vice-Chancellor had provided his apologies for this meeting.

### 3.3 HIGHER EDUCATION STANDARDS AND REGULATION

## 3.3.1 Higher Education Standards Framework

The revised *Higher Education Standards Framework (Threshold Standards) 2015* commenced from 1 January 2017 as a legislative instrument, and re-registration of the University to ensure it meets these standards is due in May 2018.

The University has established a TEQSA Working Party whose membership includes the Chair of Academic Senate. A report from the Office of Quality and Performance (OQP), including a compliance map and action plan, was noted by members via the electronic meeting of Senate conducted in December 2016. Members were provided with an updated Compliance Action Plan annotated by the Chair of Academic Senate with some other actions that Senate or its committees will contribute to.

Members were invited to raise any related matters or provide comment. No matters were raised or comments provided.

# 3.3.2 Educational Compliance Update

The University is registered as a higher education provider with the Tertiary Education Quality and Standards Agency (TEQSA) until 31 May 2018. Submission of documentation for the renewal of registration is due at least 180 days prior to this date (1 December 2017).

Academic Senate was provided with an update of the progress on:

- implementation of the HESF 2015 Compliance Action Plan, and
- the University's renewal of registration with TEQSA.

The Deputy Vice-Chancellor (Academic), Professor Denise Kirkpatrick, introduced this item, and the Executive Director, Quality and Performance encouraged members to contact her team if their work units required further clarification on the Action Plan, including the requirements of various stakeholders. There will be an update on milestones for the Action Plan, noting that these would be determined collaboratively.

#### 3.4 SENATE WORK PLAN AND SECURING SUCCESS

[Securing Success: 6.5 Promote inclusive and participatory decision-making; 6.7 Foster a strong culture and track record of successful renewal and innovation, achieved through the determination, creativity and hard work of all staff; 6.16 Aspire to the highest standards of university governance and accountability]

#### 3.4.1 Senate Work Plan

The Chair has reviewed the Work Plan following discussion and advice from the Senate Executive Committee on 10 February 2017, and making more use of the standing committees' individual work plans.

Senate was presented with a revised draft Work Plan that focuses more on Senate's own role and responsibilities, and provides further scope for Senate to hear about, discuss and advise on major academic topics.

Possible Academic Senate Priorities for 2017

- Support the preparations for the 2018 TEQSA Re-accreditation.
- Support enhancements to the student experience through coursework and higher-degree research.
- Promote a culture of student academic honesty and integrity.
- Engage with the 21st Century Curriculum Renewal project, including research dimensions of coursework.
- Contribute to further development of Western Sydney University Online Renewal and other aspects of technology enhanced learning.

The Chair indicated that he would welcome comments and advice from members to assist with further development of the Work Plan.

### 3.4.2 School of Social Sciences and Psychology Review

The School of Social Sciences and Psychology was reviewed in 2016 as part of the University's cycle of School Reviews. The terms of reference for the school review were to evaluate and provide commendations and recommendations on the extent to which the School is achieving the strategic goals and objectives of *Securing Success 2015-2020* and addressing the *2015 Higher Education Standards Framework (Threshold Standards)*. The Introductory Report and Action Plan were provided for Senate's information.

#### 3.5 TRANSFORMING WESTERN SYDNEY UNIVERSITY

On Thursday 21 July 2016 the Vice-Chancellor provided an overview of the University's current performance and financial position and key future strategic initiatives. Transforming Western Sydney University (*TWSU*) is a suite of these related strategic initiatives organised into five thematic areas, to enact the *Securing Success* strategies.

### 3.5.1 TWSU Project Update

The Deputy Vice-Chancellor (Academic) gave a progress report on the *TWSU* projects, highlighting their five thematic areas and noting the role of Academic Senate and its standing committees to progressing the 21<sup>st</sup> Century Curriculum Renewal (Structures) theme. The DVC(A) noted that 1PSQ is going well, and has attracted industry and international interest and media attention. Level 9, a public event space has been particularly successful in drawing external interest. Professor Kirkpatrick encouraged all Schools to teach at 1PSQ and to utilise the possibility of postgraduate evening classes. There are specific items in the Senate Work Plan to help achieve the goals outlined in *TWSU*.

## 3.5.2 Liverpool Campus

The Deputy Vice-Chancellor (Academic) gave a presentation on the new Liverpool campus, outlining the offerings to begin in 2018, which will help to alleviate some of the overstretched offerings on other campuses.

There was discussion from members about the lessons learned from the launch of 1PSQ, and members provided further feedback. The DVC (A) took this feedback on board and assured Senate that the transition to the new campus will be integrated, and will include change management processes, and clear communication with all internal and external stakeholders. There will be a public launch on a date to be advised in May.

## 3.6 RESEARCH

#### 3.6.1 Research Development Initiatives

The Researcher Development Initiative (RDI) was introduced in 2015 and has been offered on an annual basis. The RDI offers a suite of grants and awards focused on early career development, gender equity, and career interruption. These funding opportunities are directed toward staff members who are establishing their research profile or considering applying for their first or second round of grant funding from an external agency.

The Office of the Deputy Vice-Chancellor (Research and Development) has undertaken an evaluation of the outcomes of the RDI, and the Pro Vice-Chancellor (Research and Innovation) introduced this report. Key achievements include the gender-equity dimension, with 80% of the 174 successful award recipients identifying as female.

An acknowledgement of appreciation was given to Schools for helping to mentor successful RDI recipients in the first 12 months and beyond. The true value in this program is the continuing support and networks developed for these academics.

### 3.6.2 Summer Scholarship Research Program 2016-2017

The Office of the Deputy Vice Chancellor (Research and Development), in conjunction with Jobs on Campus, provides an excellent opportunity for undergraduate students who want to learn more about university through the University's Summer Scholarship Research Program. The Program is designed to provide students with a placement in a formal research setting where they are supervised by an academic member of staff, during the summer break. A report was provided for members' information.

#### 3.7 LEARNING AND TEACHING

#### 3.7.1 Online Education Services (OES) Partnership

The Pro Vice-Chancellor (Digital Futures) gave an update on the OES Partnership, noting that the project focuses on bringing in a diverse range of students who, through a variety circumstances, are not able to attend on-campus and therefore are seeking an online alternative study option. This is an educational space that the University is currently not utilising to its full potential.

The governance for the Project includes three working groups and one steering group working towards a September 2017 launch. Although ambitious the timeline is achievable.

There was discussion from members on how consultation for the Partnership had taken place. It was confirmed that discussions with specific Schools had begun and are continuing to take place, with the consultation to broaden as other disciplines are bought into the Partnership. The involvement of the School Academic Committees was confirmed as a key part of planning and consultation for the Project. A Frequently Asked Questions document will be shared with staff once it has been approved for publication though the Project governance processes.

#### 3.7.2 STUDENT EXPERIENCE SURVEY RESULTS

A late paper was circulated to members and the Deputy Vice-Chancellor (Academic) gave an overview of the data and encouraged members to review it in more detail.

The data in this report feeds into the larger data set that helps the University to analyse the performance of courses, including how they performing in terms of student satisfaction and employability. This will also inform the TWSU Curriculum Renewal project.

#### 3.8 RED TAPE TASK FORCE

The Red Tape Task Force (RTTF) was established to review a range of administrative tasks required in support of teaching and research programs. This initiative of the Board of Trustees aimed to identify opportunities to free up academic time currently spent on administration, while improving efficiencies and processes.

Mr Peter Tow, Director, Project Management Office, introduced an update on the current RTTF projects and noted that the Task Force is now conducting a Post Implementation Review of some earlier projects. Members were invited to raise any related matters or provide comment, and highlighted the importance of making further progress with the Career Development Planning and Review (CDPR) process and COMPASS.

**HIMAA NSW Branch ICT (HIM) Scholarship** – This scholarship is intended for new or continuing full-time students in the Bachelor of Information and Communication Technology (Health Information Management), and who maintain satisfactory academic progress.

**Hazlett Family Scholarship** — This scholarship is intended for new or continuing students in any undergraduate degree in the School of Business, School of Nursing and Midwifery, School of Computing, Engineering and Mathematics or the Bachelor of Sustainable Agriculture and Food Security, who must demonstrate financial or other hardship, and who maintain satisfactory academic progress.

**Foster Care Angels Danielle Raemer Scholarship** — This scholarship is intended for new or continuing full-time students in any undergraduate degree, who must demonstrate financial or other hardship and have been in or are currently in out-of-home care as defined by the NSW Department of Family and Community Services, and who main satisfactory academic progress.

Scenic World Scholarship in Natural Science and Tourism Management — This scholarship is intended for new or continuing full-time or part-time students in the Bachelor of Natural Science or Bachelor of Tourism Management, who must demonstrate financial or other hardship, and have resided in the Blue Mountains LGA for at least 12 months prior to commencing study, and who maintain satisfactory academic progress.

**John Mac Scholarship** — This scholarship is intended for new or continuing full-time students in any undergraduate degree, or Foundation Studies, Diploma or Associate Degree at The College, who must demonstrate financial or other hardship, reside in the Western Sydney region, and are Australian citizens or permanent residents, with a preference given to those who have been granted a humanitarian visa and who maintain satisfactory academic progress. The Education Committee met on 7 March 2017, the Assessment Committee met on 7 February 2017; and The Student Experience and Engagement Committee (SEEC) met on 1 February 2017. A combined report of these meetings was circulated with the agenda papers.

#### 4.5 ACADEMIC PLANNING AND COURSES APPROVALS COMMITTEE

The Academic Planning and Courses Approvals Committee (APCAC) met face-to-face on 28 February 2017 and 28 March 2017 and conducted an electronic meeting from 3 to 9 March 2017. The combined report of these meetings was circulated with the agenda papers.

Without discussion

#### It was resolved (AS17:02/18):

That Academic Senate notes the reports of the meeting conducted from 3 to 9 March 2017 and the meetings on 28 February 2017 and 28 March 2017 of the Academic Planning and Courses Approvals Committee and approves the recommendations contained therein.

#### 4.6 SCHOOL ACADEMIC COMMITTEE REPORTS

The 2016 Annual Reports for the following School Academic Committees were presented:

- School of Business Professor Sara Denize, Deputy Dean of the School of Business, spoke to the report. She noted the vast volume of work the committee had completed in order to facilitate the move to 1PSQ. There was discussion about the positives and negatives in the move to 1PSQ and congratulations were given for the management of this major transformation of location and curriculum.
- School of Law Dr Stephen Janes, Deputy Dean of the School of Law, spoke to the report. The SAC has been working hard on a resequencing of LLB units to ensure that students maintain good standing throughout the course. There has been a particular focus on units in legal literacy and governance, as well as the introduction of global law units (China in place, India in the pipeline). There was recognition that 85% of law students are studying double degrees, many of which are in the School of Business. The response has been a move to introduce first year units at 1PSQ. Academic Senate congratulated the Committee on being proactive in student retention and working well in supporting the transition to 1PSQ.

- Graduate Research School Professor James Arvanitakis, Dean, Graduate Studies, spoke to the report. There was an acknowledgement that this report signified the conclusion of the first year for the School, and appreciation was expressed for the work the School has achieved in this short time. The School is reviewing teaching styles and will be making more us of block delivery modes, including the introduction of a one week 'Bootcamp' to be piloted in June and then again in September to coincide with Research Week. The School is also looking to engage with the Academic Literacy Taskforce.
- School of Social Sciences and Psychology Professor Kevin Dunn, Dean of the School of Social Sciences and Psychology, spoke to the report. The SAC worked on 25 new units, 35 course variations and 75 unit variations throughout 2016, a massive achievement with a need for high levels of quality assurance.
- School of Medicine Professor Annemarie Hennessy, Dean of the School of Medicine, spoke to the report. She provided further information about the course variations outlined in the report. She also noted the importance in both reporting up and down, and highlighted to Academic Senate that this is a standing item on the Committee's agenda.

The Chair commended the work of the School Academic Committees.

# 4.7 SCHOOL/INSTITUTE RESEARCH AND HIGHER DEGREE RESEARCH COMMITTEE REPORTS

The 2016 Annual Reports for the following School/Institute Research and Higher Degree Research Committees were presented:

- School of Business Professor Sara Denize, Deputy Dean for the School of Business, spoke to the report on behalf of Associate Professor Meg Smith. She recognised the School's existing base of research and the collaborations available for Business through other Schools and the University Research Institutes; the plan is to expand this with the guidance of the Committee. The Pro Vice-Chancellor (Research and Innovation) commended the School on its positive work in implementing the University's Research and Development Plan.
- School of Law Dr Alpana Roy, Associate Professor from the School of Law, spoke to the report. Law held a successful Research Seminar Series last year. They are looking into why there was an ERA ranking drop and ways of attracting Category 2 and 3 funding, as well as maintaining a focus for Category 1. They are looking at broadening the range staff involved in HDR supervision, and REDI staff have been assisting with this. Senate was encouraged by Professor Deborah Sweeney to applaud the School on its introduction of an Impact and Engagement (Research) Officer, and for enthusiastically pursuing the research-impact initiative.
- School of Medicine Professor Annemarie Hennessy, Dean for the School of Medicine, spoke to the report. She noted the great achievement of over \$11 million in funding, and that the School is well on target for HDR students with 112. HDR completions are also going well. The Dean highlighted that the Clinical Trials Database is a significant issue for the School, and the Health Taskforce is working with other schools on this. There is also a need to

address the issue of important research being funded by non-recurrent sources.

- School of Nursing and Midwifery Professor Deborah Hatcher agreed to present her School's report at the next Senate meeting.
- School of Social Sciences and Psychology Professor Kevin Dunn, Dean of the School of Social Sciences and Psychology, spoke to the report. The number of meetings and e-meetings held was noted, with the outcome of 32 seeding grants. There are 6 groups reporting to the Committee.
- Institute for Culture and Society Associate Professor Juan Salazar, Research Director of the Institute for Culture and Society, spoke to the report. The Institute has just completed a 5-year review; they have been successful in Category 1 funding, three ARC Discovery grants and one DECRA. They are working on addressing a need to diversify the Category 2 and 3 income streams. They are developing new linkage grants, with six in the pipeline and a hope that three will get through. They have a declining number of PhD students due to a lack of funding; they are investigating the possibility of cosponsorship with industry and are looking to get more involved in undergraduate teaching.
- The MARCS Institute Professor Kate Stevens, Director of Research and Engagement, and Dr Paul Breen, Director, Higher Degree Research, from the MARCS Institute, spoke to the report. They commented that they have reached 50 successful PhD graduates from MARCS and have a very positive student experience rating. Well-established events ran well and it was also noted that non-academic ventures are going to take a new importance.
- The Hawkesbury Institute for the Environment Associate Professor Markus Riegler from the Hawkesbury Institute for the Environment, spoke to the report. He noted that the Committee is working on doubling its membership in order to address the issues with declarations of interests in such a small group. The Institute had its first two Master of Research students submit within days of the Academic Senate meeting.

The Chair commended the work of the School/Institute Research and Higher Degree Research Committee Reports, noting that they had highlighted some areas for sharing experiences and good practice; for example, in managing on-time completions for HDR students.

#### 4.8 THE COLLEGE ACADEMIC COMMITTEE

The College Academic Committee met face to face on 17 November 2016. The minutes of this meeting were provided. This matter was held over from the inquorate 9 December 2016 meeting.

The next scheduled meeting of The College Academic Committee was 9 March 2017.

#### 4.9 BOARD OF TRUSTEES

The Board of Trustees met on 22 February 2017 and 5 April 2017.
