ELIGIBILITY CRITERIA

To be eligible for a Priority Parking Permit, you must be enrolled at Liverpool City campus and meet one of the following criteria:

- Require the use of a wheelchair, crutches, walking frame or other specific mobility aid; or have a disability and/or medical condition that significantly impacts on mobility
- Be an expectant mother, whose mobility is significantly affected by their pregnancy
- Have a condition that prevents them from safely navigating paths of travel and managing public transport conditions

Please note: If you have a Mobility Parking Scheme Permit, you do not need to complete this form.

Simply present your Mobility Parking Scheme Permit to Campus Safety and Security to access Priority Parking areas.

HOW TO APPLY

All applications must be endorsed by a General Practitioner (GP), or an accredited health professional and be accompanied by an accredited health professional provider stamp or business card including registration number.

Applications will be approved for a maximum of one teaching session, but it is possible to re-apply for a Priority Parking Permit prior to the commencement of each teaching session.

IMPORTANT INFORMATION WHEN APPLYING FOR A PRIORITY PARKNG PERMIT

Western Sydney University's City-based campuses may have limited on-site parking options with very limited spaces however street parking or private car parks are available for all University students to access.

Students who hold a Mobility Parking Scheme Permit may park in designated accessibility parking spaces. Students are required to present their Mobility Parking Scheme Permit prior to the beginning of each semester to Campus Safety and Security to be provided with access to the University's priority parking.

Priority Parking Permits are available to students if they meet the criteria at the Liverpool City campus.

Eligibility criteria definitions

Professional's signature:

Require the use of a wheelchair, crutches, walking frame or other specific mobility aid; or has a disability and/or medical condition that significantly impacts on mobility

Person has a medical condition, injury or disability that can be temporary, which significantly restricts or reduces their tolerance to stand, walk or to mobilise.

Is an expectant mother, whose mobility is significantly affected by their pregnancy

Person has a medical condition or complications associated with their pregnancy which significantly restricts or reduces their tolerance to stand, walk or to mobilise.

Has a condition that prevents them from safely navigating paths of travel and managing public transport conditions

Person experiences symptoms or has a medical condition that is significantly and/or adversely affected by travelling on public transport, or significantly exacerbated with exposure to external or environmental conditions in path of travel to Liverpool campus.
