



10% ALUMNI POSTGRADUATE COURSEWORK DISCOUNT TERMS AND CONDITIONS

1. Name of Discount

- 1.1 Western Sydney University 10% Alumni Postgraduate Coursework Discount ('Discount').

2. Eligibility

- 2.1 Students are eligible for a 10% discount on the program fees for an eligible postgraduate coursework program if they:
- a) Completed an undergraduate program at Western Sydney University, including a Diploma, Associate Degree, Undergraduate Certificate, Bachelor and Bachelor (Honours) qualification,
 - b) Receive an offer to an eligible postgraduate coursework program commencing in 2025, and
 - c) Commence the program and remain enrolled past at least one Census date in 2025.
- 2.2 The 10% discount is not available for domestic students studying in a postgraduate program that offers Commonwealth Supported Places (CSP). Refer to eligible postgraduate program list (Appendix A).
- 2.3 Eligible students must commence their studies, and remain enrolled for at least one Census date in 2025. The Discount may not be available to students who defer their offer to commence in 2026. Eligibility for the Discount for deferring students will be at the University's discretion.
- 2.4 The 10% discount may be awarded in addition to any scholarships, sponsorships or other tuition fee discounts for students.

3. Value of Discount

- 3.1 10% discount in tuition fees.

4. Duration of Discount

- 4.1 The Discount is intended for the duration of the student's postgraduate program at Western, including any periods of approved leave. The maximum duration of a postgraduate program is outlined in the Progression Policy.

5. Payment Details and Conditions

- 5.1 The Discount will be automatically applied to relevant students' records and tuition fees will be calculated with the Discount.
- 5.2 Student Services and Amenities Fees are not discounted and are required to be paid by the student.



6. Termination of the Discount

- 6.1 On completion of the postgraduate program or transfer into another postgraduate program.
- 6.2 On the resignation, withdrawal, or lapsing of the student from Western Sydney University.
- 6.3 On the student no longer meeting the eligibility requirements outlined in section 2.
- 6.4 On the death of the student.

7. Appeal

- 7.1 The recipient may appeal termination of the Discount on the grounds of procedural fairness or due to exceptional circumstances by applying to the [Director, Data Integrity, Quality and Operations](#).
- 7.2 The Director, Data Integrity, Quality and Operations or nominee will consider the appeal and decide on whether the appeal is upheld, and the Discount continued, or the appeal is dismissed, and the Discount is terminated.
- 7.3 The determination of the Director, Data Integrity, Quality and Operations or nominee will be final.
