# Executive Presentation – Division of Academic and Enterprise

Professor John Ingleson, Deputy Vice-Chancellor (Academic and Enterprise), provided a presentation on the Division's key strategies and directions.

# University Governance Principles and University Legislation

The Board discussed the developments from the NSW Minister following consideration of the Report on the NSW Legislative Council General Purpose Standing Committee (June 2009): *Governance of NSW Universities*.

The Board strongly supported the continuance of a separate Act for the University as opposed to the proposal for a

general Act to cover all NSW universities which had been mooted. The Board also reviewed and supported a draft set of University Governance Principles that had been circulated by the Minister. The Board did not see the need for any major changes to the UWS Act but, given the current review, it authorised the Board Standing Committee to recommend any minor or technical changes that might be desirable.

#### Parking Fees 2010

The Board approved the CPI increase of 2.5% to parking fees for 2010. This is in line with the Board's resolution about 2009 parking fees, that increases of at least CPI should be applied to parking fees in subsequent years.

#### **Board and Committee Membership**

The Board noted that Ministerial approval had been received for the appointment of Ms Emma Stein and Mr John Banks to the Board of Trustees for four year terms. Ministerial approval has also been received for the reappointment for four years of Ms Vivienne James, Mr Glen Sanford, Mr Ian Stone and the Hon Kim Yeadon. The Board approved the appointment of Ms Kerry Stubbs, the Managing Director of Northcott Disability Services, as an external member of the Strategy and Resources Committee for a two year term.

#### **Campus Development**

The Board approved the University entering into agreements with Integral Energy for the grant of electricity easements, as detailed to the Board, on a section of the University's Kingswood campus.

Professor Kevin Sproats gave a presentation on current and future possible campus developments.

## The Margaret Whitlam Chair in Social Work

The Board approved the naming of the University's Chair in Social Work as The Margaret Whitlam Chair in Social Work. The Board requested that the University Executive review the Naming of Physical Property Policy to incorporate the naming of Chairs in addition to property matters.
