SHORT MINUTES OF ORDER:

- 1 The hearing be adjourned part-heard to 10 am on [28 October 2024] with an estimate of half a day.
- 2 The plaintiff is to file any further evidence and written submissions on which it seeks to rely by 21 October 2024.
- 3 Pursuant to s 7(b) of the Court Suppression and Non-publication Orders Act 2010 (NSW) (the Act) and on the grounds in s 8(1)(a) and (c) of the Act, that until further order there be no publication or disclosure of:
- a. the affidavit of Peter Nathan Tow affirmed 3 September 2024 including the exhibits thereto;
- b. the supplemental expert report prepared by David Ulcigrai, Director of Digital Forensics and Incident Response at CyberCX dated 3 September 2024; and
- c. the plaintiff's counsel's written submissions dated 11 September 2024 and Confidential Chronology.
- 4 For the purposes of s 11 of the Act order 3 is to apply both within New South Wales and in all the States and Territories in Australia.
