

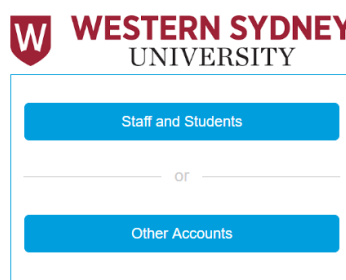
# HOW DO I CHECK MY STUDENT COMPLIANCE STATUS IN INPLACE?

## INPLACE STUDENT PLACEMENT SYSTEM

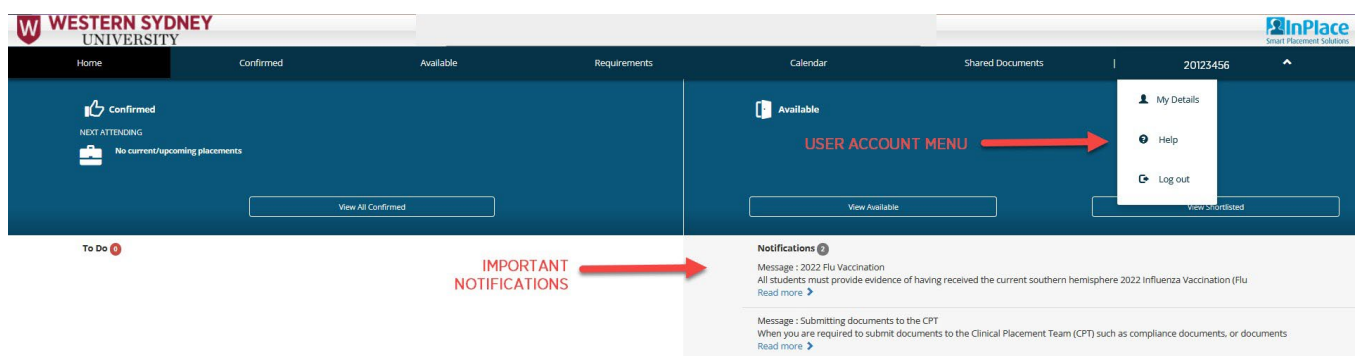
The University utilises a software system called InPlace to manage Student Compliance and placements. InPlace gives you instant access to your compliance status, Student Compliance Interview and allocated placements anywhere, anytime on any device.

Your InPlace Home screen will appear; here is an example:



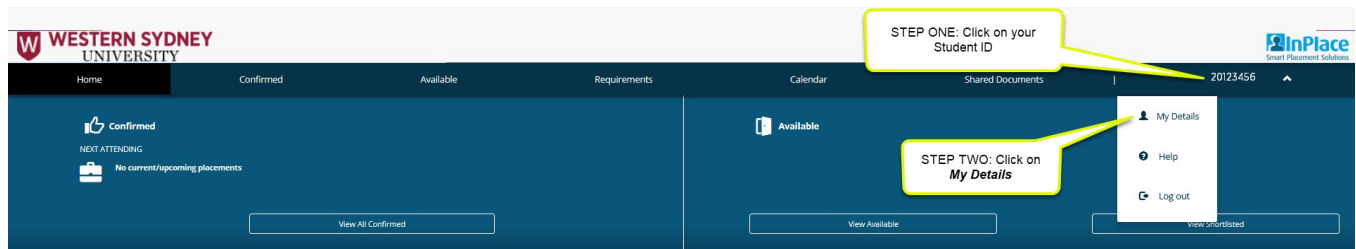
